- The CCIM had carried out an inspection of the institution on 22-23.07,2019 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. Certain deficiencies have been observed in CCIM recommendation report and therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 03.09.2019 to present the case.
- The observations of hearing committee based on submission made by the college representatives during hearing and recommendations & visitation report of the CCIM have been carefully examined in terms of Regulation 3 of the Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Sowa Rigpa Colleges and attached Hospitals) Regulations, 2017, provisions under the IMCC Act, 1970, relevant regulations made thereunder and it is found that the College is fulfilling notified and approved criterion for granting Conditional Permission for UG (BSRMS) course.
- It has, therefore, been decided by the Central Government to grant Conditional Permission to the "Central Institute of Budhist Studies (CIBS), Choglamsar, Leh- 194104, Jammu and Kashmir" for conducting 15 seats in UG (BSRMS) course for the academic Bil Tiley session 2019-20.

The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report along with its assessment in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2020-21.
