





### NOTICE

It is hereby notified to all the qualified candidates of the Ph.D. Entrance Test and Interview in various Departments of Central Institute of Buddhist Studies for the Academic Year 2025-26 that the registration process has opened. The merit list of the qualified candidates is also available on the institute's website. As such, the candidates qualified are hereby informed to abide by the following important steps:

1. A Candidate shall pay the Registration Fee of Rs. 1500/- (One Thousand Five Hundred only) to the Account Section, CIBS and collecting the slip of fee, he/ she must submit the same along with the Registration Form with the Examination Department. The Registration Form is available on the University's website to download or it may be collected from the Examination Department.
2. The last date for receipt of dully filled Registration Form is 25<sup>th</sup> July 2025 and the last date with a late fee of Rs. 200/- shall be 28<sup>th</sup> July 2025.
3. Application for Part-Time Registration should be accompanied by a "NO Objection Certificate" issued by the Competent Authority, where the candidate is employed, clearly stating that the candidate is permitted to pursue her/his Ph.D. programme on a Part-Time basis.
4. The candidates are to choice his/her Supervisors/ Co-supervisors by themselves and obtain their consent in the format provided herewith this notification through writing a formal letter to the Head of the Department concerned informing him/her about the Supervisor/ Co-Supervisor. Only a regular faculty member of CIBS having at least three years of service left shall be eligible for being a Research Supervisor.
5. The full-time regular teacher of CIBS can act as a Supervisor/Co-Supervisor within the department or other department of CIBS.
6. In case of topics which belong to inter-disciplinary/multi-disciplinary area of research, if required, a Co-Supervisor from outside the Department can be allowed with the approval of Research Advisory Committee of the Department concerned.
7. The allocation of Research Supervisor for a selected research scholar shall be finalized by the RAC of the Department concerned, depending on the number of scholars allotted to her/him, the available specialization among the Supervisors and research interests of the scholar as indicated by them at the time of interview.
