A. Quotations from interested person(s)/firms are hereby invited to run the departmental canteen of Central Institute of Buddhist Studies (Deemed to be University), Choglamsar, Leh by submitting their biddings in the prescribed proforma which can be had by the bidders from the office of CIBS, Leh during any working day. The proforma can also be downloaded from the website of the institute (www.cibs.ac.in). Duly filled proforma along with their bio-data indicating the experience should reach the office of CIBS, Leh on or before 16 March 2026. For more details, contact Mobile No. 9419343906.

B. The terms and conditions of the contract shall be as under:

1. The contract shall be initially for a period of one year extendable further depending on the service and quality of food etc., of the canteen runner.
2. The Institute may cancel/reject the contract any time without prior notice, if any misconduct done by the canteen runner.
3. The Institute will provide rent-free space, drinking water and furniture to the lowest bidder. However, actual electricity charges shall have to be borne by the canteen runner.
4. The canteen runner shall maintain proper hygiene.
5. The canteen runner shall not engage/ associate any student of CIBS, Leh with his/her business, which will hamper the study of the student concerned.
6. The canteen runner shall not sell cold drinks and any obnoxious items in the canteen.
7. The canteen runner shall have to deposit a security deposit of Rs. 50,000/- (refundable) in advance.
8. The bidder shall submit the day-wise menu from Monday to Saturday based on the items mentioned in the proforma
9. In addition to food items, the canteen runner may also keep all stationery items and other essential items suitable for the students in the canteen for sale. The items should sell on 10% less than market rate. Besides, a Xerox Machine may also be installed in the canteen at the rate of Rs. 2/- per page.
